### **PUBLIC RELEASE SY 2020-2021 Community Eligibility Provision**

Crowley County School District RE 1-J is participating in a Universal Breakfast and Lunch Program for the current school year 2020-2021. All students enrolled at this school may participate in the breakfast/lunch program at no charge to them.
